GNT semifinals pit East vs. West and North vs. South



East plays West and North opposes South in today's 64-board semifinals of the Flight A Grand National Teams. In Flights B and C, teams will compete in 32-board quarterfinal matches this afternoon. The

four winners in each group then will compete in 32-board semifinal matches this evening.

Representing the East in Flight A is the District 3 team made up of New York and New Jersey players. Playing with Captain Luella Slaner of Scarsdale NY are Joel Friedberg, Scarsdale; Steve Weinstein, Glen Ridge NJ; Ethan Stein, Irvington NY; Fred Stewart, West Hurley NY, and Marty Bergen, Farmingdale NY.

They will play a California team representing District 22: Ross Grabel, Huntington Beach; Jon Wittes, Claremont; Mark Itabashi, Murrietta; Fred Hamilton, Fresno, and Gene Simpson, Redlands.

In the other semifinal it's Illinois (District 13) vs. Texas (District 16).

On the Illinois team are Tom Fox and Dick Melson, Chicago; David Lehman, Glenview, and Walter Schafer Jr., Bloomingdale.

The Texas team consists of Bobby Goldman, Highland Village; John Sutherlin, Mike Passell and Malcolm Brachman, Dallas, and Eddie Wold, Houston.

8 inducted into Hall of Fame

Eight all-time bridge greats were inducted into the ACBL of Fame at the annual Hall of Fame dinner here last night. Three of the four living aces were on hand to accept their "Academy Awards" -- (Hall of Fame Chairman Larry Cohen's words) -- and the fourth sent his acceptance and thanks via a video. Once again, David Ezekiel of Bermuda did an outstanding job as master of ceremonies.

John Gerber

George Rosenkranz, a bridge great in his own right, was the presenter for John Gerber, a great player, captain, coach and adviser. "John was my mentor,

my guru, my friend," said Rosenkranz.

"John had a different view of the game from most of us. I didn't agree with him, but that didn't keep him from being a winner. He believed winning was a result of play and defense. Bidding was a definite last in his view. But he had a great eye for talent and he had uncanny analytical ability. I remember how he would sit in the lobby and everyone would come to him for advice and counsel."

Gerber perhaps is best known for the convention he invented -- the four-club ace-asking bid -- which bears his name. He won four North American cham-

Charity Foundation makes two special donations

Former Miss America Mary Ann Mobley's role as a spokesperson for the Crohn's & Colitis Foundation of America (CCFA) is not merely a case of a celebrity assisting a charitable cause. Mobley herself is one of the estimated two million Americans who live with Chron's disease and ulcerative colitis.

Mobley, who has appeared on *Designing Women*, *Diff'rent Strokes* and *Falcon Crest*, accepted the check for CCFA with Emmy award winner Gary Collins. Collins is also well known for his work on the *Home* show and *Hour Magazine*. The couple serves as co-

chairs of the CCFA's Celebrity Club, and Mobley also serves on CCFA's national Board of Trustees.

CCFA's national chairman Scott Allswang said, "We are pleased to accept this generous donation from the ACBL Charity Foundation. Our organization, which was founded in 1967, spends 81% of its funds directly on research and education, an excellent record for a non-profit group."

Mobley and Collins also thanked the players in attendance at the Charity Game Thursday evening for their generous support to find the cure for these mysterious diseases.

The ACBL Charity Foundation also donated \$5000 to Kindness Is Doing Something Special for Kids (KIDSS for Kids), a Chicago-based charity. The all-volunteer organization is dedicated to improving the quality of life of children battling serious illnesses.

KIDSS for Kids President Rob Feldgreber, along with fellow representative Michael Goldman, accepted the check on behalf of the organization.

"Our group is an auxiliary of Children's Memorial Medical Center. Starting in 1991, we were assisting 15 families and had a fundraising goal of \$5000. In just a few short years, our program has grown to assist some 250 families who have donated over \$1 million to Children's Memorial."

This accomplishment makes KIDSS for Kids one of the fastest-growing benefactors of the Children's Memorial Medical Center and the largest contributor to its various Family Support Services programs.

"Our group is dedicated to helping the whole child. Special emphasis is given to emotional healing of the child and his or her entire family," said Feldgreber.

Computer competition begins today

The Baron Barclay/OKbridge World Computer Bridge Championships, scheduled to begin today, will truly be international in scope.



Competing in the main event will be Hans Leber (*Q Plus Bridge*) from Germany, Tomio Uchida and Yumiko Uchida (*Micro Bridge 8*) from Japan, Mike Wittaker (*Blue Chip Bridge*) from Great Britain, along with U.S. participants Matt Ginsberg (*GIB*), Don Farwell (*Bridge Baron 8*), Rolf Wilson (*Bridge Genii*) and Rodney Ludwig (*Meadowlark Bridge*).

Competing in the bidding contest only will be Vince Oddy (*BridgeWare*) from Canada and Bob Richardson (*Bridge Mate 3*) from the U.S.

Kibitzers are welcome.

The contest begins as a round-robin, with the top four programs advancing to the semifinals on July 26. The finals are scheduled for Thursday, July 30.

A 16-board match is scheduled July 28 between the computer programs and four-person Junior teams. The sponsors, Baron Barclay and OKbridge, will contribute \$500 to the Junior program and Junior participants are eligible to receive a one-year membership to OKbridge (or a one-year extension if already a member).

The computer bidding contest is scheduled for July 29.

A special Computer vs. Expert match between *GIB* and Zia-Michael Rosenberg is scheduled July 28, and can also be seen on OKbridge.

Play or defend?

This interesting deal came up in a qualifying match in the Canadian Open Teams Championship. Would you rather play or defend the spade slam?

Naturally the opening lead is a diamond -- 9, queen, king, ace. Clearly declarer can't knock out the trump ace immediately -- the defense will cash a diamond. Somehow declarer must get rid of a diamond from either his hand or dummy.

How about cashing his top clubs and getting to dummy with a heart? Then he can lead a high club and overruff when East trumps in. Then he can cross to dummy again with a heart and lead another high club. Once again he overruffs East. Now East is out of trumps, so declarer can ditch dummy's last diamond on the ♥Q. Making 6♠.

But wait a moment! We assumed that East would ruff clubs both times. What if East ditches his second heart after declarer gets to dummy with a heart the first time? Now declarer can't rid of his troublesome diamond and has to go down one.

pionships, represented the United States in the 1961 Bermuda Bowl, and captained the American teams in world championships on several occasions.

Alphonse "Sonny" Moyse

David Berkowitz, another who already has made his reputation as a bridge great, was the presenter for Alphonse "Sonny" Moyse, a fine player who perhaps earned more fame for his work for *Bridge World*.

"Sonny was a traditionalist," said Berkowitz. "He believed you should have clubs when you bid clubs and hearts when you bid hearts." However, he recognized the inevitability of science making its mark in bridge.

Moyse, *Bridge World* in the era between Ely Culbertson and Edgar Kaplan, was famous for his love of playing 4-3 trump fits. He became such a champion of this fit that it is now known world-wide as the Moysian Fit.

Peter Pender

Hugh Ross, presenter for Peter Pender, recalled that he first ran across Pender in 1966 -- and "only" 15 years later Peter asked Hugh if he wanted to form a serious partnership. The partnership worked -- they won many world championships together in the Eighties. A major reason for their success was their attitude -- "We agreed to disagree," said Ross. "There was never even a trace of resentment."

Ross told about Pender's trip to Perth, Australia, for the 1989 Bermuda Bowl to illustrate how strongly Pender was willing to work to make his point. Pender qualified for Perth, but the Australian government learned he suffered from AIDS and refused to allow Peter into the country. Well, Peter called the ACBL and the World Bridge Federation, the American government and the Australian government, newspapers and magazines, TV and radio stations. Finally an embarrassed Australia allowed him to come to play -- and the city of Perth gave Peter the keys to the city.

Peter won a Bermuda Bowl and was second in another. He also had 13 North American championships to his credit.

Dave Treadwell

Henry Francis told about Dave Treadwell's entry into duplicate bridge more than 50 years ago. David went to the Boston Chess Club without a partner. They found him a partner and he came in second. "Easy game," he thought. But he changed his mind when he failed to make average his next five outings. That was a challenge, a challenge he has been meeting ever since.

His three children -- Martha, Dave and Tony -- were all on hand to watch him accept his honor. He was the Blackwood Award recipient -- the award that goes to a player who has made outstanding contributions to bridge away from the bridge table. He was chairman of the Board of Governors for three years and a chairman or co-chairman of the Appeals Committee for 24 years. He also has been president of both his unit and his district. But he's a fine player as well -- a Grand Life Master with two North American championships in his portfolio.

When Dave went to the podium, he told how he had been asked not to tell any of his stories -- Dave has earned his reputation as a great story teller many times over. Then the emotion of the occasion got to him. His voice broke as he said, "Thanks to all the people who have made this possible."

Alvin Landy

"The ACBL owes a huge debt to Alvin Landy," said Dick Freeman, presenter for Landy. Freeman pointed to the many changes Landy made in ACBL practices -- bigger and better monthly Bulletins, an improved tournament program, upgraded administrative practices, etc. Landy was the winner of the Von Zedtwitz Award, whereby contributions to the game of bridge through bridge-playing expertise are recognized.

Landy is the only player in history to win the Men's Teams four times -- a record that can't fall because there are no more North American Men's Pairs events. His first major victory occurred in 1936 when he won the American Bridge League's Knock-out Team Challenge. Landy also won a Spingold and

Billy Eisenberg

"The maverick of all mavericks" was the way presenter John Solodar classified Billy Eisenberg. Billy, because of a scheduling conflict, was not present to accept his honor, but modern technology made the difference here. He prepared a video which was shown to the gathering at the banquet.

"I am with you because of modern technology," said Eisenberg. "I am very thankful for all that bridge had done for me. I hope to have the opportunity to return something to the game."

Billy has won five Bermuda Bowls, and he credited "fine partners" for his success. His partners were Bobby Goldman, Bob Hamman, Fred Hamilton and Eddie Kantar (twice).

Mary Jane Farell

"She's been playing bridge since she was 17," presenter Roy Green said of Mary Jane Farell. "She is well-known for her Coffees with Mary Jane. Even the *Los Angeles Times* recognized her achievements -- in 1964 she was named Woman of the Year."

"I've had a wonderful, wonderful 60 years in bridge," said Mary Jane. "The best thing that ever happened to me in bridge was meeting my wonderful husband Jules."

Mary Jane also had something to say about another Hall of Fame inductee. "I never played as a partner with Dorothy Truscott, but when I played on a team with her, it was always a great comfort to know she was in the other room. She is a good friend."

In 1978 Mary Jane and Marilyn Johnson won the six-session Life Master Pairs, the only women's pair ever to triumph in this event. At the world level she is a Grand Master with several world championships

to her credit.

Dorothy Truscott

"Dorothy Truscott has an amazing commitment to win," said presenter Gail Greenberg. Then she told the story of the 1990 Women's KO Teams. "It finished in the early morning hours, and it was a tie. Originally we were given the option of playing the extra eight boards the next day, Then somebody told the other team we were a team of grandmothers, so suddenly they wanted to play right away."

"Let's show them something about grandmothers", is what Dorothy told us. And we proceeded to mop them up in the playoff, finishing about four in the morning. I was so tired I didn't play in the Mixed Teams, but when I went downstairs that afternoon, there was Dorothy at the table, looking as bright and perky as ever."

"I've been extremely lucky all my life," Dorothy said. "I have had wonderful partners -- people like B. Jay Becker and Emma Jean Hawes. And now I have my husband Alan backing me. Not only that, but three of my daughters are here with their husbands tonight." Watching as their mother was honored were Margaret Cooke and her husband Jim, Cathy Thurston and her husband David, and Bobette Thorsen and her husband Todd.

Dorothy has won all manner of world and North American women's championships, but the achievement she treasures most is a second-place finish. She was a member of the U.S. team that finished second in the Bermuda Bowl in 1965. She has four world championships and more than 30 North American titles to her credit. □

Chicago NABCs: a look back

Chicago hosted its first NABC in the fall of 1927 and its last in the summer of 1989 -- this is the 15th NABC hosted by the Windy City

Attendance figures for the early tournaments are not available but the *Auction Bridge Magazine* reported that "complete success in every respect marked the first tournament under the auspices of the American Auction Bridge League in Chicago" in December 1927.

"All of the events were keenly contested. The total number of competitors exceeded 300, making a remarkably formidable presentation of high grade talent."

Less than 40 years later, the 1965 Summer NABC drew a record 14,511 tables.

The *Bridge Bulletin*, reporting on the record-shattering tournament, noted that Chicago "marked a milestone in the new era of the super tournament with a smoothness and efficiency that had to be seen to be believed."

A highlight of that tournament was a repeat win in the Spingold by the all-star Canadian team of Eric Murray, Sami Kehela, Percy Sheardown and Bruce Elliott. With their win, the Canadians became the only four-man team to boast back-to-back victories in the Spingold.

West found the only lead that would give Murray -- and his optimistic slam -- a chance: the ♥2. Murray won East's 10 with his ace and immediately ran the ♥8.

When this lost to the king and a third heart went to dummy's queen, Murray was home. He cashed one high trump in dummy and followed with two top spades and a spade ruff.

Now he cashed the ♦A and ruffed a diamond, ruffed his last spade and cashed dummy's ♣Q. He ruffed a diamond and drew the last trump.



The Summer NABC returned to Chicago in 1971 and, once again, the Spingold had a repeat winner. The original Precision Team -- Tom Smith, Steve Altman, Joel Stuart, Peter Weichsel and David Strasberg -- won in Boston in 1970. With Gene Neiger replacing Strasberg, they took the championship in Chicago the next year.

Despite his seven-card spade suit, Neiger (West) elected to pass throughout. As a result, declarer went wrong in the play.

With no reason to suspect an unbalanced hand on his left, declarer assumed the club lead to be fourth-best. He had some work to do in the minor suits anyway and elected to play low from dummy.

East won the ♣K and returned the 7 as a suit preference signal for spades. Neiger ruffed and dutifully returned a low spade. A second club ruff set the contract one trick.

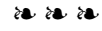

Put yourself in the East chair: since declarer can get rid of a diamond on the third top heart and diamonds are favorably placed for declarer, how can you beat this game?

Mike Passell found a way. When declarer took the spade finesse at trick two, Passell won with the ace. Next he cashed the ♦A and continued a diamond, declarer winning the king.

At this point, declarer could make his game by cashing three rounds of hearts but what was the point? He could take the "proven" finesse against the ♠Q, draw trumps and take his discard with impunity.

It didn't work out that way. A spade to the jack -- and Passell won his ♠Q and cashed the ♦Q for the setting trick.
