Quinn team captures NA Swiss in squeaker

In a race that went down to the wire, the team captained by Shawn Quinn won the Bill Keohane North American Swiss Teams. Five squads were within 4 Victory Points with one round to go.

Quinn was leading after day two and held her lead until the after round six on Sunday. They lost two rounds, but rallied to win the final round by 16 victory points to edge the Dan Morse team by less than 2 VPs.

The winners are Shawn and Joe Quinn, Richmond TX; Renee Mancuso, Los Angeles; Rebecca Rogers, Las Vegas; Pamela Granovetter, Cincinnati; and Barry Rigal, New York City.

The second place team was Dan Morse, Houston; Greg Hinze and Ira Hessel, San Antonio; Nagy Kamel, Plano TX. Morse was originally third but a late appeal dropped the Wayne Stuart team from second to to fifth. Morse team won its last round, but not by as big a margin as the Quinn team.

Shawn Quinn and Renee Mancuso put together the team. Pamela Granovetter and Barry Rigal had not played as partners before. "I made Barry play many of my methods," said Granovetter, who, along with husband Matthew Granovetter, founded Bridge Today magazine.

Joe Quinn is an engineer who "supports my bridge habit," joked wife Shawn. Barry Rigal is a well-known bridge author and columnist. Beside playing bridge, Mancuso is an accountant.

All of the team members previously had NABC titles, except Rogers. "I'm glad to get it," she said. "I'm closing in on 10,000 masterpoints and needed it for Grand Life Master." Rogers and Jeff Meckstroth won the World Mixed Pairs in Montreal in 2002.

Rice team wins Junior Trials

The team captained by Mike Rice won the Junior team trials over the Eric Mayefsky squad. They will be team USA II at the WBF Youth Championships to be held in Bangkok, Thailand, Summer of 2006.

Nickell runs away with Reisinger again

For the second year in a row, the Nick Nickell squad won the Reisinger Board-a-Match Teams in runaway fashion. Trailing by less than half a board going into the final day of play Sunday, the team surged into the lead and built on it steadily.

The final margin over the runners-up – George Jacobs and company – was nearly five boards.

Nickell was playing with Dick Freeman, Jeff Meckstroth, Eric Rodwell, Bob Hamman and Paul Soloway.

Jacobs' team was Ralph Katz, Zia Mahmood, Michael Rosenberg, Alfredo Versace and Lorenzo Lauria.

Nickell's big win helped make up for the disappointment of the team's loss to Italy in the final of the Bermuda Bowl in Portugal earlier this month. "We needed something to get back on a good keel," said Eric Kokish, coach of the Nickell team. Kokish said Meckstroth and Rodwell were especially strong in the final two sessions, and he credited their playing together in the Blue Ribbon Pairs for sharpening their game.

The victory was Rodwell's 39th North American title, Meckstroth's 38th. They have won the Reisinger seven times. Hamman's Reisinger record is even better – he has 11 wins in arguably the toughest event on the ACBL calendar.
