## Spunky Laura Plunkett, 90, targets Diamond LM status

When 90-year-old Laura Plunkett returned to bridge after a 30-year hiatus, she had about 1900 masterpoints and a goal -- to earn 600 points and become a Gold Life Master.

That was three years ago, and she's well past 2500 points now. In fact, the Huntington Beach CA resident is only about 15 points shy of 3000, and she's not about to let up. Her new goal is 5000 MPs, which will make her a Diamond LM.

No one who knows Plunkett, a competitor at the Fall NABC, doubts she will reach her new goal. In the past year, Plunkett has won 11 regional championships, nine of them knockouts. "She's always in the top bracket," said Gene Simpson of Redlands CA, one of Plunkett's regular teammates. "She's never played in the second bracket."

At the Modesto CA regional last month, Plunkett, her regular partner Nunzio Martorina of Corona and Simpson won two KO's in one day.

"In one of the matches," Simpson said, "I thought

we were down about 30 IMPs after what happened at our table, but when we compared with Laura, she had such a good game we were six IMPs ahead."

Plunkett took up bridge in 1958, "when my husband traded me in for two 20s. Bridge helped me through the divorce and it's helping me through my old age."

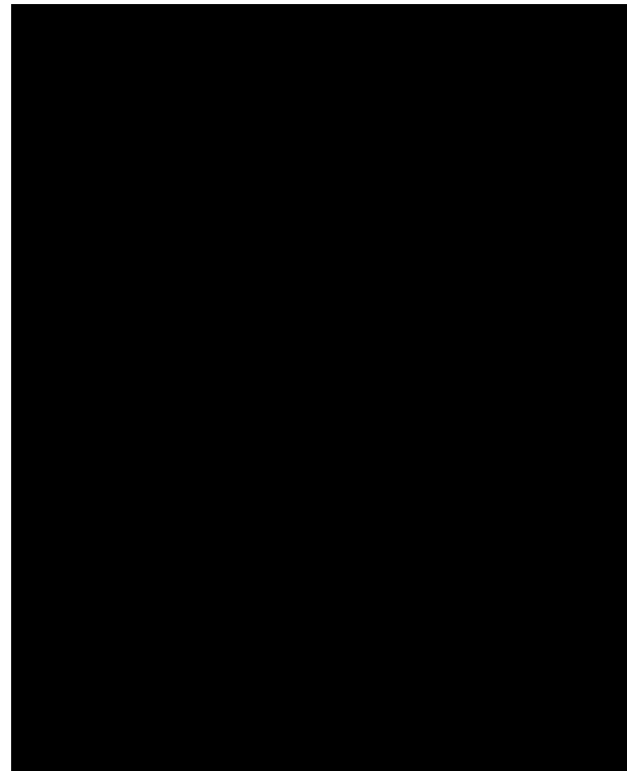
"Old age" are not two words you would associate with the spry, energetic and absolutely fearless Plunkett.

"When I started," she said, "I played against all the old tops (players). I worked at it and studied a lot, and the only time I wasn't playing was when I was traveling to another tournament. I never missed a tournament."

Plunkett, living in Los Angeles at the time, remembers playing against the likes of Barry Crane, Hermine Baron and Lew Mathe "practically every day."

The second year she was playing, she opposed the legendary Helen Sobel at a tournament. After

## Forrester, Helgemo lead Blue Ribbon Pairs

Tony Forrester of Great Britain and Geir Helgemo of Norway, who came up just short in a major pair event at the last NABC they attended, took the lead in the Blue Ribbon Pairs with two rounds to go.

At the Summer NABC in Miami Beach, the internationalists were leading in the Life Master Pairs with a round to go but ended up in second place. In the Blue Ribbon, Forrester and Helgemo led after both semifinal sessions.

Mixed pairs made up places two through four in the event. In second were Michael Rosenberg and

## Over 10,000 today

San Francisco 1996 will go over the 10,000-table mark sometime this evening. As play got under way today, the table count was 9245. Attendance will fall off today because it's Thanksgiving, but there won't be any problem getting to 10,000.

Every day it looks more and more as if this tournament will become the biggest San Francisco NABC in history. The record is 13,239 (1990), and that certainly is well within reach now. Even 500 tables a session the rest of the way would do it, and chances are we'll do a lot better than that.

## AIDS Memorial quilt on display

The panel of the AIDS Memorial quilt honoring the members of San Francisco Unit 506 who have died of AIDS is now on display in the Yerba Buena Ballroom, Salon 8.

The panel was originally constructed in 1989 by members of the San Francisco Unit to honor the memory of their fellow duplicate players who had died of AIDS. The quilt panel has been updated twice since then, most recently in August for display at this tournament.

## Top seed advances, No. 2 falls in Senior Knockout

The top-seeded squad captained by Mary Chilcote advanced to the semifinal round of the Senior Knockout Teams with a convincing 185-93 victory over the foursome led by Louis Quiggle.

Chilcote, of Cleveland OH, is playing with Zeke Jabbour and Billy Eisenberg, Boca Raton FL; Fred Hamilton, Fresno; Tommy Sanders, Nashville, and Russ Arnold, Miami.

The No. 2 seed, led by Trudi Nugit of Bel-Air, did not fare as well. A final-round rally by the Nugit squad came up short and the team lost to the Howard Hertzberg team, 136-120.

Hertzberg, of Alpine NJ, is teamed with Robert Ryder, Caldwell NJ; William Esberg, Elberon NJ; Simon Kantor, Agawam MA, and Martin Baff, Beachwood OH.

In other matches, the team led by Virgil Anderson Jr., originally seeded 19th, was leading the squad captained by Ed Barlow, 129-55, when Barlow withdrew after three quarters. Anderson, of Springfield MO, is playing with Jayne Thomas, Lutz FL; Liane and Donald Turner of Kansas City KS, and Mary and Roy G. Green of Memphis.

The Colin Revill squad also benefited from an early exit by their opponents. Revill and company were leading the Robert Carteaux team, 145-62, when Carteaux threw in the towel.

## Hart to retire after San Francisco NABC

Twenty-six years ago, Nancy Hart was between jobs and living in Toronto when some friends had a chance to buy a duplicate bridge club. The only problem was that they had no one to run it.

Hart, who had been hoping to continue her career in radio, was drafted to run the club.

Thus was launched a directing career that has spanned more than a quarter of a century.

"I've never looked back," said Hart, who

is now looking ahead to retirement. The Fall NABC will be her last, and she doesn't equivocate about the reasons.

"I'm 60, my husband Dick is 70," she said. "The Harts have places to go, things to do and people to see."

Hart isn't leaving directing completely -- she's planning to work in the Toronto area wherever she's needed -- but she won't have

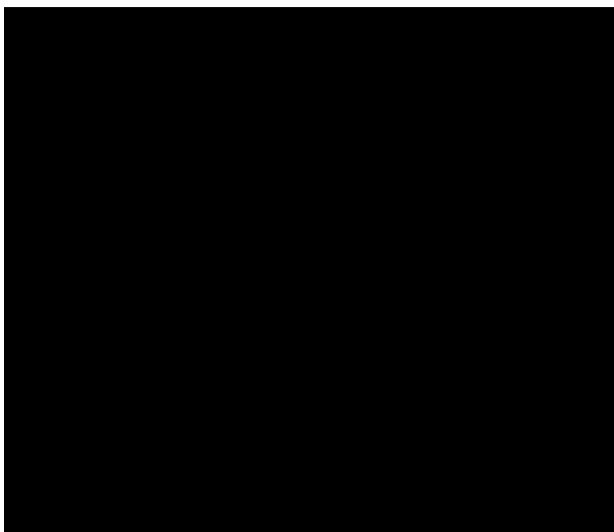

Declarer won the club and immediately led a trump. Michael Rosenberg contributed the 9, so Zia knew his partner was ready to ruff the next club. He led a high club, suit preference. Rosenberg ruffed and underled his ♥A. Zia won and gave Rosenberg a second club ruff to beat the contract.

It should come as no surprise that Zia is an imaginative declarer as well. This deal comes from the first final session of the Open BAM.

The opening heart lead went to the 9 and 10, and Zia won the club shift with the king. Figuring that almost all the missing high cards must be with South, Zia led a spade to the ace, disdaining the finesse. South hadn't reopened the bidding at the two level, so Zia thought it likely he didn't do so because he had diamonds. So he took a finesse to the jack and cashed the ace and king of trumps.

Next came the ♣A, and he got out of his hand with a trump to South's queen. South already was endplayed. He tried the ♥A and followed with the ♥Q which Zia ruffed. Next came a spade to South's bare king, and South had to lead a heart to dummy's king where Zia had the good ♠Q waiting. As a result Zia wound up with nine tricks -- plus 140. At the other table his teammates defeated 2♦.

Ron Smith led a diamond, and declarer won the king with the ace. He tried the ♣Q and Smith ducked smoothly. Next came the ♣10, and Smith ducked equally as smoothly. So declarer let it ride and Glubok won with the jack. He could have guaranteed the defeat of the contract by leading back a diamond, but he of course realized that declarer must be looking for the ♣A.

Glubok knew who had it, so he led a heart right into dummy's king. When declarer then cleared clubs, the door of the Trojan horse opened and out poured the hearts. Smith led a heart, and when the smoke cleared declarer was down two instead of one.

In second seat, Toni passed, deciding against opening a weak 2♦ because of her good major-suit holdings. Her left-hand opponent opened 1♣ and Eric -- "my very *solid* partner" -- bid 2♣, a Michaels cuebid showing both majors.

Toni inwardly congratulated herself for not opening 2♦. "Now," she continued to herself, "I can bid my vulnerable game."

While she was contemplating whether to simply sail into 4♣ or bid 4♣, letting Eric pick the trump suit, RHO bid 5♣!

Oh no, thought Toni, they're saving. Toni whipped out her double card.

LHO mumbled, stewed and finally reached into his bidding box and pulled out. . . *seven clubs!* This was followed by three passes.

Said RHO, "You double 5♣ but not seven?" So at this first opportunity to play clubs, West took a finesse, losing to North's singleton king.

"This," says Toni, "is called the *pseudo striped-tailed ape double*."

The clubs dropped on the ace for 13 tricks.

Bramley of course was the captain of the American Open team in the recent World Team Olympiad in Rhodes, Greece. He disagrees with the *Bridge Bulletin* report that his team had problems with the opponents' unusual bidding systems.

"We were ready for their systems, and in general we handled them well. The big problem was that those teams with unusual systems were scoring blitzes against weaker opponents because those teams didn't know how to handle such unusual bidding. We weren't getting as many wipeouts because our systems were much nearer the norm."

Bramley also feels his team should not have suffered from jet lag. "We got to Greece three days before the tournament. That seems like enough time to get back on line timewise."

## Bidding Box Caddy

A new product called the Bidding Box Caddy is being tested at this tournament. The caddy attaches to diagonal corners of the table and provides a place off the table for bidding boxes and/or drink containers.

The purpose of the caddy is to reduce clutter and box spills, increase visibility and generally improve the playing surface. According to the producers, the caddy will adjust to a wide range of table sizes.

Hampson led a heart to Feldman's ace, and he played the ♠8 to the queen and Deas's king. Deas could not return a minor suit without costing the defense a trick. A trump return would have been best, but she played a heart.

Feldman ruffed and took his first good view by leading a low club from his hand. Hampson won the ♣K and played a third heart. Feldman ruffed again and did well for the second time to lead a diamond to the queen. Now a heart ruff completed the dummy reversal, and Feldman played two more rounds of trumps, throwing a diamond from his hand. This was the ending, a variation of a stepping stone squeeze:

At this point, Feldman knew East had started with 3-3-4-3 or 3-3-3-4 shape. So he played the ♣Q, overtaking with the ace, and cashed the ♣J. If East had started with four clubs, the ♣7 would have been high. East, however, discarded on the second club, so Feldman fell back on his second chance. He led the ♦K, dropping the jack and took the 13th trick with the ♦10 to make his contract.

trouble filling her days. The Harts live in Cobourg, about 75 miles east of Toronto, in a house built by a lake in 1907.

"I can garden, spend more time with my grandchildren," she said, "and Dick and I can go to things like golf club dances that happen on Saturday nights."

Hart was a bridge player before being drafted to run the Regal Bridge Studio in Toronto, but she wasn't a director. She quickly took the training, however, and dove right in.

At the Toronto regional in 1970, she came in second in the Mixed Pairs and went to work as a director the next day. "That was the last session of bridge I played since," she said, adding that in retirement she hopes to take up playing again.

Husband Dick has represented Canada in international competition. "I've got a built-in super-star partner who's very pleasant."

Hart treasures her experiences as a director. "As a group," she said, "bridge players are the most interesting people you could possibly deal with. They're bright and enthusiastic, although it is a challenge sometimes to deal with them."

At NABCs, Hart does a lot of work in the Intermediate/Novice games. Her real specialty, said NABC Director-in-Charge Tom Quinlan, is the fast open pairs. "She's the queen bee of the fast games," said Quinlan. "She really whips them into shape."

Hart will miss the tournament scene, but she said, "I think the ACBL needs some new faces."

Besides that, she said, her husband has been very patient with his absentee wife during 20 years of marriage. She recently made his day when he approached her with the news that their financial situation would allow her to cut back on directing -- if she wanted to.

"When I told him yes," she said, "he had such a big smile on his face." □

defending a deal against Sobel, Plunkett was taken aback when Sobel said to her, "That's the best defense I've seen at this tournament."

Plunkett quit playing in 1965. There were the pressures of business -- she ran a mobile home park -- and her mother's illness, which took up her time for seven years. Various factors kept her away from the game almost entirely until her return about three years ago.

"Now," she said, "I'm footloose and fancy free and living for bridge." She knows that playing as much as she does can be expensive, but she said, "What the hell. I can't take it with me."

Plunkett has won nearly 400 masterpoints in 1996 despite illnesses that kept her out of action for the better part of four months. She's feeling fine now, however, and ready for battle.

Plunkett loves to play in good company. "The bigger they are the better I like to play against them," she said. "Bridge is a challenge. It's exciting and I love to gamble but not with money. I gamble at bridge. You give me 10 points and you can't shut me out."

Still a tigress at the table, Plunkett does allow that she's "not as good as I used to be."

Said Simpson: "I just hope I can play as well as she does when I'm 90." □

## Too much pressure

On this deal from the Stratified Open Pairs Wednesday, West could have played a high card early to save himself the pain of being strip-squeezed by Mark Itabashi. If that had happened, of course, there would have been no story to tell. Itabashi, of Murrieta CA, was playing with Nancy Borucki of Monterey.

East led the ♣10. Despite lots of high-card points, the North-South hands had only nine top tricks. Somehow, Itabashi was going to have to come up with three more. Initially at least, Itabashi had reason to regret not rebidding 1♠ -- a suit contract at least had the benefit of ruffs in each hand.

Anyway, Itabashi won the club lead with the ace and played the ♠A and the ♠K, noting East's discard (so much for a spade contract). Next came a low heart from dummy. West could have settled matters for the most part -- Itabashi still had to guess diamonds -- by rising with the ♥K, but he ducked. Itabashi put in the queen and began to get a clear picture of East's hand when East followed with the ♥J, almost certainly a singleton.

With two major-suit singletons, East was a heavy favorite to hold length in diamonds, so Itabashi played the ♦J from his hand, letting it ride when East played low. When West showed out, Itabashi had a complete count of both opponents' hands.

He played a diamond to the king, cashed another spade in dummy and played the last spade to his queen, then followed with the ♦A, pitching dummy's ♣3.

West was strip-squeezed. He had to retain three hearts, or Itabashi could simply duck a heart to end up with three tricks in that suit. To hold three hearts, West had to come down to a singleton club.

Itabashi then played a club to dummy, removing West's last club, and played the ♥8 away from the ace. West won the 9 but was forced to surrender the 11th and 12th tricks by leading away from his ♥K into dummy's A-10.

**The Facts:** 4♥ went one down, minus 50 for N/S. North pulled South's slow double of 3♠ to 4♦ and finished in 4♥. East, who had summoned the Director after North bid 4♦, sought redress. The Director ruled that it would have been a logical alternative for North to pass South's double of 3♠ and that the tempo of the double made it more likely that it would be successful for North to take it out. The Director canceled the table result and replaced it with Average Plus for E/W, Average Minus for N/S.

**The Appeal:** N/S appealed. N/S agreed that the double of 3♠ had been out of tempo. North asserted that she would have bid 4♦ regardless of the tempo of the double because her hand was worthless on defense.

**The Committee Decision:** The Committee decided that South's tempo break before doubling 3♠ suggested some uncertainty and could have suggested that it would be more successful for North to take it out than it would be to leave it in, and that pass was certainly a logical alternative. Pursuant to Law 12C2, the Committee canceled the table result. The more difficult decision was the score adjustment. The Committee concluded that there was at least a one-in-six chance that N/S would go minus 530 against 3♠ doubled, and at least a one-in-three chance that East, given the clues available to him from the auction, would achieve that result by playing for ace-and-one diamond on his left. The Committee therefore assigned 3♠ doubled made three to both pairs; plus 530 to E/W, and minus 530 to N/S. Chairperson: Jan Cohen

## Overtricks pay off

Bruce Ferguson frequently brings good hands to the Daily Bulletin. The hero always is somebody else, never Bruce Ferguson. This time the tables are turned -- one of Ferguson's opponents came to us with a fine Ferguson hand. It occurred in the second final session of the Open Board-a-Match Teams.

Since North had doubled diamonds, South led that suit and Ferguson ruffed. He led a spade to the ace and ruffed a spade. This was followed by a diamond ruff, a spade ruff and a third diamond ruff. He led a fourth spade, and when North followed, he ruffed with the jack. When South failed to overruff, Ferguson knew where the queen of trumps was, but it wasn't necessarily going to be easy to pick it up.

He cashed the ♣A and decided that South's 9 was a true card, which meant that North started with three trumps to the queen. Ferguson next took his ♦A and led a heart to the ace. When he then led the good spade, North was helpless. If he ruffed, Ferguson would overruff, cash the trump king and win the last trick with the ♥K. If North discarded, Ferguson would sluff his heart. With the lead in dummy at trick 12, he would have no problem taking the last two tricks.

So Ferguson took all 13 tricks. And that overtrick was necessary to win the board because his opposition got to 6♣ at the other table. The opening lead there was the ♥Q. Declarer won this and attempted to cash the ♥K -- oops! This got ruffed, of course, and now declarer had to be careful to make six. He eventually guessed correctly to take a ruffing finesse against the ♠K to make 12 tricks -- but that still was a loss on the board.
