

## Atwater, Pesce top Red Ribbon Pairs

Rich Atwater of Tacoma WA and Chris Pesce of Seattle practically made it no contest in the Red Ribbon Pairs when they piled up a 74.78% game in the first final session. Bob Sievers of Champaign IL and Georgia Heth of Peoria IL had two fine 60% games, but that still left them more than a board behind the winners.

Atwater and Pesce were only 39<sup>th</sup> after the qualifying session, but that giant game put them ahead of the field by three boards going into the second final. During that huge session they scored more than 75 matchpoints out of a possible 90 on half the boards. Two of the boards were complete tops.

Did they play a phenomenal game? No, they said. "We are very grateful to our opponents for self destructing," said Pesce. "There were lots of better players out there, but we had good fortune" was the way Atwater put it.

Atwater, a computer salesman, and Pesce, a math teacher and an attorney, have been playing together for only two years. They play a two-over-one style with Bergen raises.

They also played in the Red Ribbons last year and they qualified for the final. How did they do? "We don't know," said Pesce. "We were so bad we didn't even look at the scoresheet."

Sievers and Heth also are a two-year partnership. Incidentally Heth will be the new District 8 representative to the Board of Directors, replacing former ACBL President Glenn Smith. They also play two-over-one.

"I think our steady play is the reason why we came in as high as second," said Sievers. "During the final two sessions we never had a complete catastrophe – we scored at least 15 points on every board."

## No thanks, I'll earn it

At last summer's NABC in Toronto, 16-year-old Ryan Humphreys was erroneously listed as the fifth member of the knockout team in the Educational Foundation KOs that included his grandparents Burrell Ives and Joy Humphreys playing with Ed and Cynthia Schneider. Ryan didn't actually play on the team, but he received the 25 gold-point award anyway for the team's second-place finish. When he got notice of the points in the mail, he contacted tournament director Sol Weinstein and had them removed.

This year, he was again listed as the fifth player of the same team in the same event, and again the team came in second. This year, however, Ryan *did* play and earned 21 gold points for his efforts.

## Sokolow, Holtz are LM Pairs champs

The 2002 Life Master Pairs saw a suspenseful conclusion as a pair that led most of the final session was eclipsed by another that surged at the very end. Tobi Sokolow and Leni Holtz emerged as the winners of the six-session, three-day event, posting a final score of 2135.43 matchpoints to finish a half board ahead of Lynn Deas and Curtis Cheek at 2098.71.

Sokolow, of Austin TX, and Holtz, of Los Angeles, have been friends for some time, but they had never played together before this event. Sokolow has 12 previous NABC titles, but this is her first victory in an open event. Holtz won the 1988 Red Ribbon Pairs, but this is also his first open win.

Amongst a flood of players wishing the first-time winners congratulations, Holtz repeatedly described his partner's performance as "amazing", while Sokolow praised Holtz as "unbelievable and the most fun to play with!"

Sokolow is a real estate broker and a self-described aspiring artist in portraiture. Holtz is the executive director for West Coast ad sales for Lifetime Television.

Deas and Cheek led by a full board after the first final session, while Sokolow and Holtz were fifth. Deas and Cheek remained near the top of the leader board throughout the second session and were back at the top with one round to go. A flat final round, however, allowed Sokolow and Holtz to seize the crown.

In third with 2090.08 was yet another mixed pair, the husband-wife duo of Chip and Jan Martel.

Your partner's exuberance has put you in a sticky position. East wins the ♠A and returns a spade, West playing the 3. Plan the play. *Thanks to Eddie Kantar for the problem.*

## Solution to Quiz #3

The contract is 4♥. West leads the ♥5. Plan the play.

*Kantar's answer:* You must assume trumps are 3-2 unless you enjoy playing for practice. Win the ♥K, lead a diamond to the ace and ruff a diamond, but not with the ♥2. Lead a heart to the ace (but not the duece), and begin to run diamonds until someone ruins your fun by ruffing. (You are discarding clubs.) The worst from your point of view is for the third diamond to be ruffed. The opponents can then cash two clubs and play a spade. Assuming it is East that leads the spade, win the ace and enter dummy with your precious ♥2, and discard your remaining three spades on dummy's good diamonds.

This line of play works any time trumps are 3-2 and diamonds no worse than 4-2. (Note: The way the cards lie in the diagram, you can get home by winning the ♥K and immediately playing three top diamonds, shedding two clubs as East ruffs high. South now has two additional trump entries to establish the diamonds. This line just happens to work because the player with the long trump has the shorter diamonds. If the player with the doubleton trump had a doubleton diamond the contract could collapse with this line of play.)

## Cheeky endplay

Curtis Cheek reported the following amusing deal from the first qualifying session of the Life Master Pairs. Cheek was playing with Lynn Deas.

(Rotated for convenience.) Cheek, South, declared 4♥ on the lead of the ♦10: 2, 7, ace. After drawing trump, declarer eliminated clubs and exited with a diamond. East won the king perforce and, unwilling to break spades for declarer, got out with a club. Cheek pitched a spade from hand and ruffed in dummy before exiting again with a diamond. This time West won the trick, but had no defense. A spade would allow declarer to play the suit for no losers, while another club would give declarer an 11<sup>th</sup> trick via another ruff and sluff.

After endplaying each opponent in the same suit, Cheek made five for a great score.

## Whatever happened to field protection?

The following letter was sent to the Daily Bulletin concerning the article about the Becker hand on page 4 of Daily Bulletin #3.

Re the "Act of Kindness" report: I wonder if the pairs who finished less than half a board behind Becker and Schwartz see it as such. The numerous other pairs who had one of the matchpoints taken away probably weren't thrilled either. Being careful is part of the game.

This isn't to fault Becker and Schwartz for accepting the gift – they have no obligation to act to their own detriment. Also, the Johnsons surely thought they were being sportsmanlike. The fault lies with articles like the one cited. It's 180 degrees from what should be done: emphasizing that, at matchpoints, the points you give away aren't entirely your own.

Courtesy and good deportment are fine things. I've used my office as best I can to make them happen. Pseudo sportsmanship at matchpoints is a different thing. Please say so prominently and frequently.

We have taken this hand up with the tournament director who writes the Ruling the Game column for the Bridge Bulletin. Based on what the article says, he believes the bid should not have been retracted. He feels it was a change of mind, not an inadvertent mistake. Apparently no tournament director was called – the players apparently decided how to handle the situation.

The primary purpose of the article was to show how well Mike Becker played the hand after discovering he had only one heart stopper. However, it was necessary of course to tell what happened to explain the very strange bidding diagram.

Probably it was a mistake on our part to feature the "Act of Kindness." And it appears that the change of bid should never have happened. But that takes nothing away from the fine play Becker gave a difficult hand.

Tom Weik of Reading PA found his way to nine tricks on this deal from the first final session of the Life Master Pairs. On the way he applied strong pressure on both his opponents

East won the first trick with the ♣K and alertly switched to a trump that rode to the queen. Weik called for another club, won with the ace, and East returned a second trump to the ace. Then Weik applied the pressure – he ran all of his trumps. This was the position:

Now Weik cashed the ♦A, and East had a problem. If he pitched a club, he knew declarer would cash the ♣Q and throw him in with a club. That would force East to give up a trick to dummy's king. So East bared his ♥A.

Weik was ready for that – he led his heart, forcing East to win. East had to return a club to Weik's queen, but now Weik played his low diamond, forcing West to win and give Weik his ninth trick with the ♥K.

East–West found the superb Moysian fit. Even a trump lead doesn't hurt declarer; there's no way to prevent Zia from scoring six top tricks in aces and kings along with four other tricks from ruffs. Plus 620 earned the pair 61 out of a possible 64 matchpoints.



# Tournament appeals

In order to keep the bridge public informed of appeals results in a timely fashion, the NABC Daily Bulletin staff publishes write-ups. Every effort is made to ensure that these reports are accurate and complete. However, before they are published in the NABC Appeals Casebook revisions may be made.

## Case 1

**Subject:** Misinformation:

**Event:** GNOT Flight A, first semifinal session

**The Facts:** 6♣ went down nine, plus 450 for N-S. The opening lead was the ♥J. The Director was called at the end of the play. When the tray returned to the S-W side of the screen on the second round of the auction, West asked about North's 5♣ bid. South wrote: "usually lead directing, could be suit, but not likely"). North did not offer any explanation of the bid to East. West believed that South's statement that North was unlikely to hold a club suit misled him, causing him to treat East's 6♣ bid as natural rather than a cuebid, as intended. The Director ruled that South's statement was that 5♣ was "usually" lead directing but that North "could" have a suit. Therefore, there had been no misinformation and the table result would stand.

**The Appeal:** E-W appealed the Director's ruling. The E-W team captain attended the hearing and acted as an interpreter for E-W, who spoke little English. The case was heard between sessions and the Screening Director indicated that there had not been sufficient time to do a screening. The E-W team captain reiterated West's belief that South's explanation, which included the statement that North was unlikely to hold a club suit, misled him into interpreting East's 6♣ bid as natural rather than a cuebid.

The Committee asked E-W several questions. When asked what it would have meant if East had doubled 5♣ instead of bidding 6♣ both East and West agreed that the double would have been penalty.

When asked why he thought East had bid 6♣



immediately rather than double 5♣ first, West thought for a while and, after some discussion with his partner (in Polish), indicated that 6♣ probably showed a better hand with clubs while a double would have shown clubs but would not have been forward-going.

When asked what a pass of 5♣ by East would have meant, E-W both said it would have been forcing.

When asked what East's 3♥ bid meant, E-W indicated that East could have either a long, solid minor suit looking for a heart stopper for notrump or a spade-minor two-suiter. (N-S then pointed out that West's own minor-suit holdings eliminated the first hand type as a possibility.)

N-S both stated that they did not believe that 5♣ was Alertable and that South had made it clear that they (N-S) had no agreement about the suit's length. A bid like 5♣ in an auction such as this was usually lead directing but need not be a suit, although it might be. When South was asked about his double of 3♥ he said it was to let North know that he could lead his suit if he ended up being on lead. It did not suggest a desire to compete further.

**The Committee Decision:** The Committee believed that South's explanation of 5♣, while perhaps not worded optimally (he might have written "usually lead directing; no agreement as to length"), nonetheless made it clear that North had not guaranteed club length but that he might have it. West chose to focus on the phrase "usually lead directing" to the exclusion of the rest of the statement and inferred that North would not have a club suit, a conclusion not justified by South's actual statement. Thus, the Committee concluded that there had been no misinformation. In addition, the Committee believed that North's 5♣ bid when South had not indicated a willingness to compete (only that he could stand a heart lead from North) itself carried the suggestion of extra distribution in the form of a heart-club two-suiter.

The fact that East could have doubled 5♣ for penalty to show clubs and then bid 6♣ later suggested that West's interpretation of 6♣ as natural was not justified. East might also have chosen to cuebid 5♥ over 5♣ to avoid the "ambiguous" 6♣ bid. The Committee decided that the clues from the auction strongly indicated that 6♣ was not natural and that West's decision to treat it as such was unrelated to South's explanation. The Committee therefore allowed the table result to stand.

They then considered the merit of the appeal. While everyone agreed that the appeal at least bordered on lacking merit, the combination of the language problem at the table and the fact that there had not been time to screen the case were deemed sufficient not to issue an Award Without Merit Warning.

## Smoke gets in your eyes

Fighting the effects of jet lag, I missed the best line here in my search for a second overtrick in my 4♥ contract.

Many hours of sleepless contemplation suggests that best defense is a club lead. To protect against the stiff ♥K onside, you lead low to the ♥J, then try the ♦K. If the defense ducks, you pitch the rest of your diamonds on dummy's clubs. So West wins and returns another diamond.

You take in dummy, run the ♥10 (no matter whether it is covered), play the ♣A and ruff a club. Then you go to the ♠K and lead the fourth club (intending to pitch a diamond and ruff a diamond to hand if East discards). When that all passes peacefully, you go to dummy with the ♠A and lead from dummy for the trump coup.

If the defense plays back a spade at trick four, you win the ace and run the ♥10, play a spade to the king and ruff a spade, cross to the ♦J to ruff a spade, then go to dummy's top clubs to run club winners for the coup again.

A typical hand against Sam Lev always seems to see him two levels too high and finding a way home. If you ever get a good board against him, beware! He'll get it back on the next deal. Boards 19 and 20 were typical.

Can you blame Jeff Aker for leading a spade? That is normal – but it gave declarer the extra entry for the spade finesse and two heart finesses. On a club lead, Lev would do best to win the queen and take the spade finesse. It holds. Then he would advance the ♥9! Assuming I remember to duck, declarer has only 11 tricks.

Offsite parking also is available under certain conditions. Anyone using offsite parking must stay at the tournament for a minimum of four days. Those who use the offsite plan are escorted to the North Virginia suburbs and will be driven back to the area when they are ready to leave. For further information contact David Rodney at the Marriott Wardman Park Hotel. A shuttle schedule is available at the Information Desk. If you have a return reservation and wish to make a change, it is necessary to let Mr. Rodney know at least 24 hours in advance.

Of course you can use the Metro – the Red Line's Woodley Park/Zoo stop is near the hotel. It runs to 2 a.m. on weekends.
